**Regular Meeting:**

**Update for Legislative Action on Appointment vs. Election:** Eric Magette provided an update to the Board regarding the current status of the legislative action on appointment versus election of library board members. Eric Magette indicated he went to Topeka and testified before the legislative committee regarding the need for elected board members. The legislatures did inquire when said elections would be held, even or odd numbered years. Eric Magette advised that the bill will be going before the house floor for debate and the process was moving forward. Eric Magette noted that Commissioner Dorsey and Representative Amyx have been extremely helpful in the process.
